Lawyers are an integral part of the mediation. I actively engage parties and lawyers to take a decision through self- determination. I am fully invested in my mediations - when I mediate, the case is on my mind until it resolves. I have been a mediator since 2007, working full time since 2010. I have mediated several hundred cases with a settlement rate of over 80%, covering complex commercial disputes such as company, breach of contract, construction, intellectual property, partnership, disputes between members of society/association, employer/employee, vendor, banking, developer/owner, landlord/tenant, property, family, matrimonial and other civil disputes. I have Co-mediated sensitive cases with former Judges of the Mediation Experience Supreme Court of India. As Founding Coordinator of the Bangalore Mediation Centre, the court annexed mediation program of the High Court of Karnataka, I was responsible for setting up and overseeing the effective working of the Mediation Centre.
